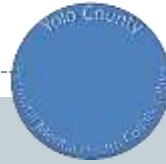

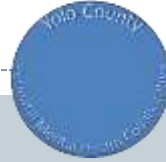
# Yolo County MCAH



## How Yolo County MCAH is leveraged to address Maternal Mental Health...

- **FIMR Community Action Plan** identified the issue as a priority.
- **FIMR Case Review Team** has key individuals/providers from stakeholder agencies/champions.
- **CPSP/Perinatal Services Coordinator** facilitates the County Wide Stakeholder Collaborative and addresses access issues r/t CPSP providers.
- **MCAH Coordinator** translates needs into action plans and oversees evaluation and reporting components of activities.

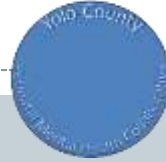

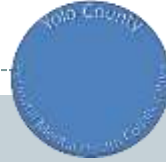
## How we got here...

- **March 2013** – MCAH Title V Needs Assessment – MMH selected as top priority
- **May 2013** – FIMR Case Review Team selects MMH as top priority / **FIMR 5 yr report\***
- **August 2013** – MCAH SOW local objective 2.4 written to address MMH

*A lot of research, networking and planning happened....with a lot of help from 2020MOM*

- **March 2013** - Launched Yolo County Perinatal Mental Health Collaborative
- **April – September 2014** Team building, action plan, mission statement, research base
- **October - March 2015** Blue Dot campaign development, mapping project development
- **April – May 1, 2015** – Blue Dot Campaign launch, align action plan w/MCAH 5 year plan to allow for Yolo County MCAH to continue to lead work, launched website\*\*
- **May 2015** – Promote Blue Dot Campaign on Facebook
- **June 2015** – Birthday Party for Yolo County PMHC

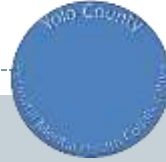




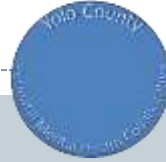
# Yolo County Fetal/Infant Mortality Review (FIMR)



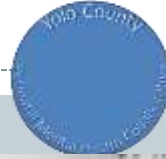

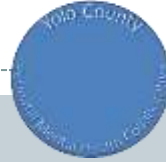
